<u>June Usage</u>. Residential demand this month averaged just over 8,600 gallons. The average use last June was just under 10,000 gallons, and in June 2015 was about 9,100 gallons. We encourage you to use what you need – no more, and no less.

Office Closure. The office will be closed July 3rd and 4th in observation of Independence Day. You can call the office and leave a voice mail on administrative matters, and you can call (505) 604-5935 if you have a water emergency.

<u>Hardness</u>. We measured hardness at the office this morning and it was 31 grains. Based on our total pumping in June, it averaged 27 grains throughout the month. A grain is approximately 17.1 milligrams per liter. We expect hardness to drop a little in July, to about 28 grains (over much of the water system).

Bill Payment – Automatic Payment Authorization. From time to time, bill payments are subject to delays associated with one, or all, of the following – delay in mailing, delay in payment from the bank, postal processing delay, or delay in receipt processing. Regardless of cause, a late fee accrues to payments received after the deadline. One option to ensure timely and accurate payment is an automatic payment authorization, and there is no charge for this service. We offer three options on withdrawal dates (5th, 15th and 20th of each month), and an authorization can be withdrawn at any time, by you. Call the office for details or assistance. This nonprofit entity was organized to help coordinate fire-related information in the east mountain area in all four counties. Their web site is www.emifpa.org. While our Drought Condition is NORMAL, the recent fire near Golden highlighted the impact the hot temperatures of June have had on the area, and the fuel load around our communities. A screen print of the EMIFPA web page this morning contained THIS information.

Wildfire risk is VERY HIGH throughout the region, and will remain so through the long holiday weekend.

Fireworks use completely banned in Bernalillo Co. portion of East Mountains.

- Fire Danger Level for both Mountainair and Sandia Ranger Districts and Bernalillo County is now *VERY HIGH*, with Stage II Fire Restrictions in effect.
- RED FLAG (all or part of area): none declared at this time
- ACTIVE FIRE WITHIN AREA: No major fires remain active within the area at this time.
- Rx BURN(S) WITHIN AREA: None are underway or scheduled.
- OTHER HAZARDS WITHIN AREA: High fuel load, extremely dry conditions
- REMINDER: Localized *flash flooding* and *debris flow* will be possible 'downstream' from Dog Head, throughout the Summer, after heavy rains on or near the area burned last June.
