Your Septic System—Unseen Yet Vital to the Environment The Entranosa Water & Wastewater Association is the largest supplier of domestic drinking water in the East

Mountain Area of Bernalillo and Santa Fe Counties. Entranosa is completely dependent upon groundwater for its source of drinking water. New Mexico's Environment Department has cited septic tanks as the single greatest source of contamination of ground water in the State. Scheduled removal of septic solids with tank and drain field maintenance are critical in avoiding liquid waste contamination into the ground water.

• In October 2000, the membership approved a Bylaw addition that required participation in a septic pumping program for all



new memberships and transfers. Members located in a subdivision, HOA or community where septic pumping services are provided will be exempt from this policy but must provide proof of participation. Members participating in the Entranosa Septic Program will be required to fill out a questionnaire that answers questions on tank size, date last pumped, how many people living in the home, knowledge of tank/riser location, tank installation date and contractor. Based on the answers to the questionnaire, Entranosa will determine a pumping schedule between 1 to 7 years.

• Members will be charged monthly septic program fees based on the pumping schedule and Entranosa will contract for pumping services to ensure tanks are pumped and cleaned on a regular schedule. Slight Increase in Fees for 2020

On January 23, the Entranosa Water &

Wastewater Association Board of Directors approved the calendar year 2020 budget. Included in the budget are multiple line replacements as older sections of the system are 40-years-old and cause higher than normal leaks. Included in the budget is \$577,000 in capital projects that will improve water flows, along with development of a fifth well at Pine Canyon. The Board of Directors and staff are working on a long-range strategic business plan that will identify future system improvements, and membership growth and funding. To fund this year's improvements, contained within the 2020 budget are several rate changes including: A 3-percent water rate increase and an increase in meter base fee, and increases in the administrative fee for membership transfers and rental properties. The average bill will

increase approximately \$2 per month. These increases will take effect February 1, 2020 and will show up on members' March bills. The entire budget is available for review
