Important Entranosa Water & Wastewater Changes

RFP for Septic Pumping Services

To protect ground water, Entranosa requires members to have their septic tanks pumped and assess a monthly fee that goes toward those pumping costs. Because of the contracted annual volume, pumping costs per tank are significantly discounted, saving members over \$100 per tank. To fulfill the RFP, Entranosa will select a pumping service based on: Experience, capacity, performance and price. Entranosa's septic pumping customers are selected annually by date of previous service, which is based on size of household, not tank size. The successful proposer must provide a cost per tank for a minimum of 450 tanks per year. The selected pumping service company will be expected to provide a fixed cost over a three-year contract period, with an option to renew for an additional two years with a negotiated price.

May 1, 2019 - RFP released and advertised

June 1, 2019 - Proposals due by 5pm. (Hand delivered, emailed or mailed)

June 14, 2019 - Interviews

June 21, 2019 - Staff recommendation to the Board of Directors and Notice of Award

August 1, 2019 - Contract begins

Changes to By-Laws

During the Board of Directors May 23 meeting, revisions to Entranosa Water

New Well Coming on Line in 2020—Sweet!

Recently, Entranosa purchased it's fifth well, dubbed "Pine Canyon East." Here, Tommy Muller is flow testing the new well. This new well should produce approximately 350-400 gallons per minute. Pine Canyon wells are approximately five miles west of Stanley and produce "sweet water" with a hardness level of only 12 grains. The new well should be in full production in time for the 2020 pumping season.

Highlights of May Entranosa Board Meeting

from PulakosCPA presented the audit results for 2018. Clean audit, no audit adjustments, no management letter required and the Board can rely on the accuracy of monthly financial statements.

Board approved the changes to the By-Laws. At the last annual meeting, membership gave the Board approval to modify the membership definitions. The new definitions help to clarify membership types and eliminates different types of uses. The Board approved changes to the meter installation. The Board recently approved a change to the water contract that requires an isolation valve only for new construction. For an additional \$100, all new meters could have an isolation valve, increasing installation from \$1,475 to \$1,575. An

installation from \$1,475 to \$1,575. An isolation valve allows the homeowner to turn their water on/off without calling Entranosa. The audit and all approved changes will be posted to the website in June.
