red, white and blue under the big tent. But the meeting also features real business: Three Board positions are on the ballot, currently held

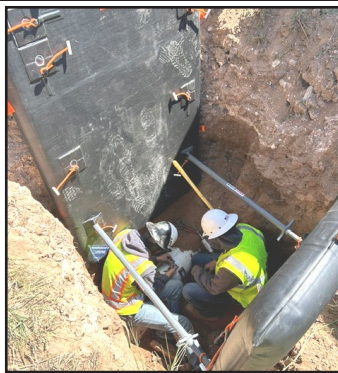

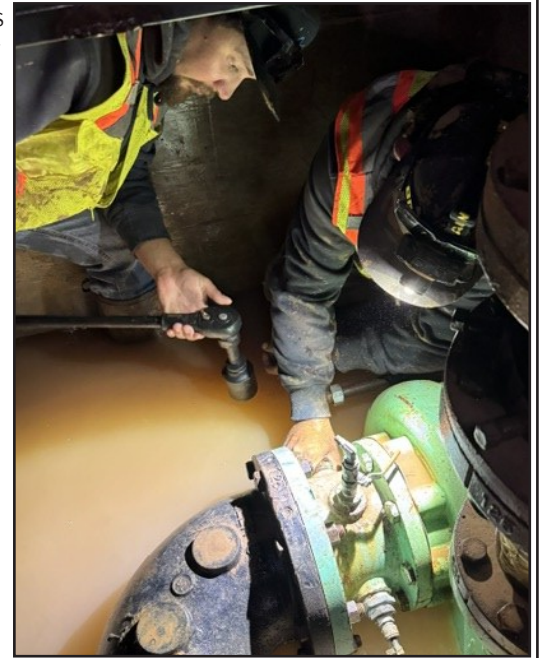
