

## Notice of Annual Meeting October 10, 2019 - 6:00 PM

The annual meeting of the Entranosa Water & Wastewater Association will be held at the **Nature Pointe Community Center**, **30 Nature Pointe Dr. Tijeras**, **NM 87059 at 6:00 P.M. on Thursday October 10, 2019**. We will place directions on our web site, newsletter and have maps available at the office. There will be dinner by \_\_\_\_\_\_ and music by Anthony Ortiz from 4:30 pm to 6:00 pm. (To assist in preparation, please **R.S.V.P. BY 10/1/19** if you'd like to attend the dinner). As stated in the Bylaws, the purpose of the meeting is to elect Directors and to act on such other business as may be properly transacted.

There are two open Board positions this year, and you have several ways to cast your **Official Ballot: 1**) you may mail the ballot to Entranosa, but it must arrive prior to 4:30 P.M. on the 10<sup>th</sup> of October; **2**) you may cast your ballot at the Entranosa office, during business hours or by dropping your ballot through the mail slot in the door, at any time prior to 4:30 P.M. on October 10<sup>th</sup>; or, **3**) you may attend the meeting and cast your ballot there. Once the meeting starts at 6:00 P.M., the Board Chair will close the election and the ballot box will be sealed for counting. Pursuant to the Bylaws, all ballots will count toward a quorum for the meeting. On October 10, 2019 - we will continue to accept ballots at the office until 4:30 P.M., at which time we'll move the ballot box and registration books to the meeting place. The meeting will begin precisely at 6:00 P.M. Your **Official Ballot** is included with this notice- **PLEASE DO NOT LOSE IT.** While **we will issue replacement ballots under certain circumstances, it is best to not have to do so - so <u>please</u> <b>don't lose it**.

The goal for this year's annual meeting is to keep the length of Board and staff presentations at a minimum, which will provide more time for member questions and answers. More detailed information will be available at staffed information tables before and after the meeting for members who have more time and questions. The meeting will end no later than 7:00 P.M.

The Board has authorized a \$5 credit toward your water bill for each attending member, as an incentive to attend, but the credit will only be applied if you have a meter. In addition, we will be giving away door prizes including \$25, \$50, \$75 and \$100 water bill credits, Entranosa Hats with our logo and water pressure gauges. To be eligible for door prizes, you must attend the meeting. Names will be drawn during the meeting and a list of winners will be posted for pickup after the meeting.
