






Crews put the finishing touches on the Sandoval Lane mainline extension

Drought Update—Not Great for Bernalillo County The

monsoon

rains have eased drought conditions over much of the state, with 66.7% now in Severe Drought (down from 99.4%) and only 4.5% of the state in Exceptional Drought (Down from 52.1%) over the last three months. Bernalillo County, unfortunately, has not shared in this improvement and is still classified as being 100% in Severe Drought (D2)



Potable Water Harvesting Guidelines



Bernalillo County has developed standards for potable water harvesting systems. Besides determining what makes a safe system, this will allow systems to be permitted, which can help people obtain

Megan Marsee, Water Conservation and Resource Manager Natural Resource Services, sent this in response to a request from the Sustainable East Mountain Water Group: Bernalillo County has adopted and incorporated the Uniform Plumbing Code (UPC) into Bernalillo County Code (Chapter 10, Article II, Section 10-34). We currently enforce the 2015 UPC, which provides requirements for potable rainwater harvesting systems. The requirements address design, construction, maintenance, water quality sampling and minimum water quality standards, and connection to public water systems. Plumbing staff have developed brief Guidelines for Residential Potable Rainwater Catchment System Permit Applications, stating that these systems shall meet the minimum requirements in the current UPC and designating the Building Department Plumbing Section as the "Authority Having Jurisdiction" for permitting. Bernalillo County residents wishing to construct a residential potable rainwater harvesting system can permit that system through Bernalillo County, if it meets UPC requirements.
