Entranosa is currently test pumping our newest well, the East Pine Canyon, before bringing it fully on-line by mid-September. We first introduced members to the Pine Canyon well in February of this year. The East Pine Canyon well is Entranosa's fifth well. A pumping test is a field experiment in which a well is pumped at a controlled rate and water-level response (drawdown) is measured in one or more surrounding observation wells and optionally in the pumped well (control well) itself. Response data from pumping tests are used to estimate the hydraulic properties of aquifers, evaluate well performance and identify aguifer boundaries.

FHG Tank Selected

At the August 20,

2020 Board of Directors meeting, the Board selected FHG Tank to build a 500,000-gallon tank. The slow-down in the oil and gas business has created an excellent opportunity for water utilities to add more storage. This year's drought and heat wave demonstrated the need to expand our storage capabilities. The 38year-old company performs work East of the Mississippi and in Texas, Arizona and New Mexico.
